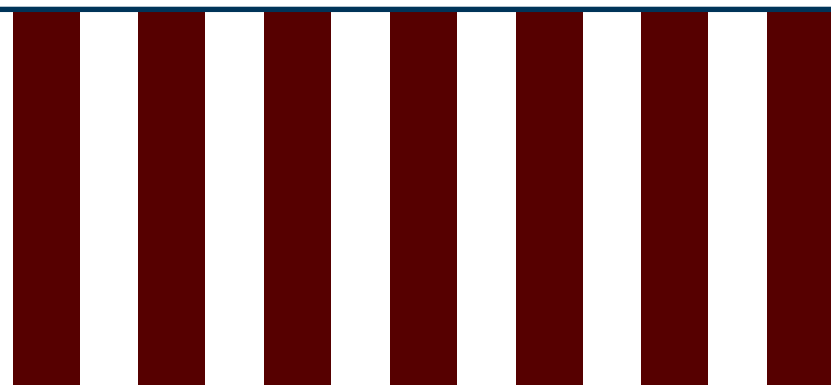
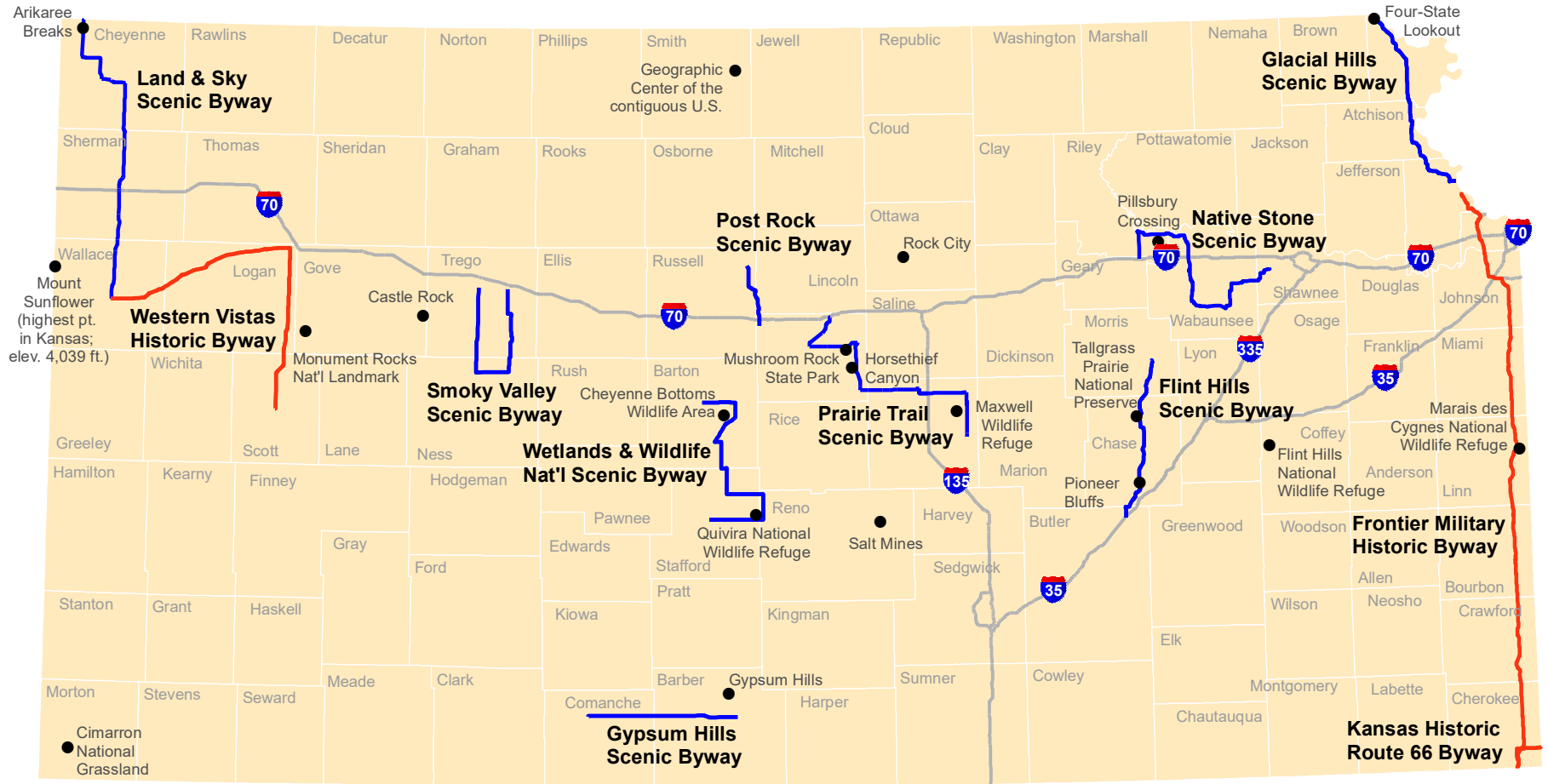

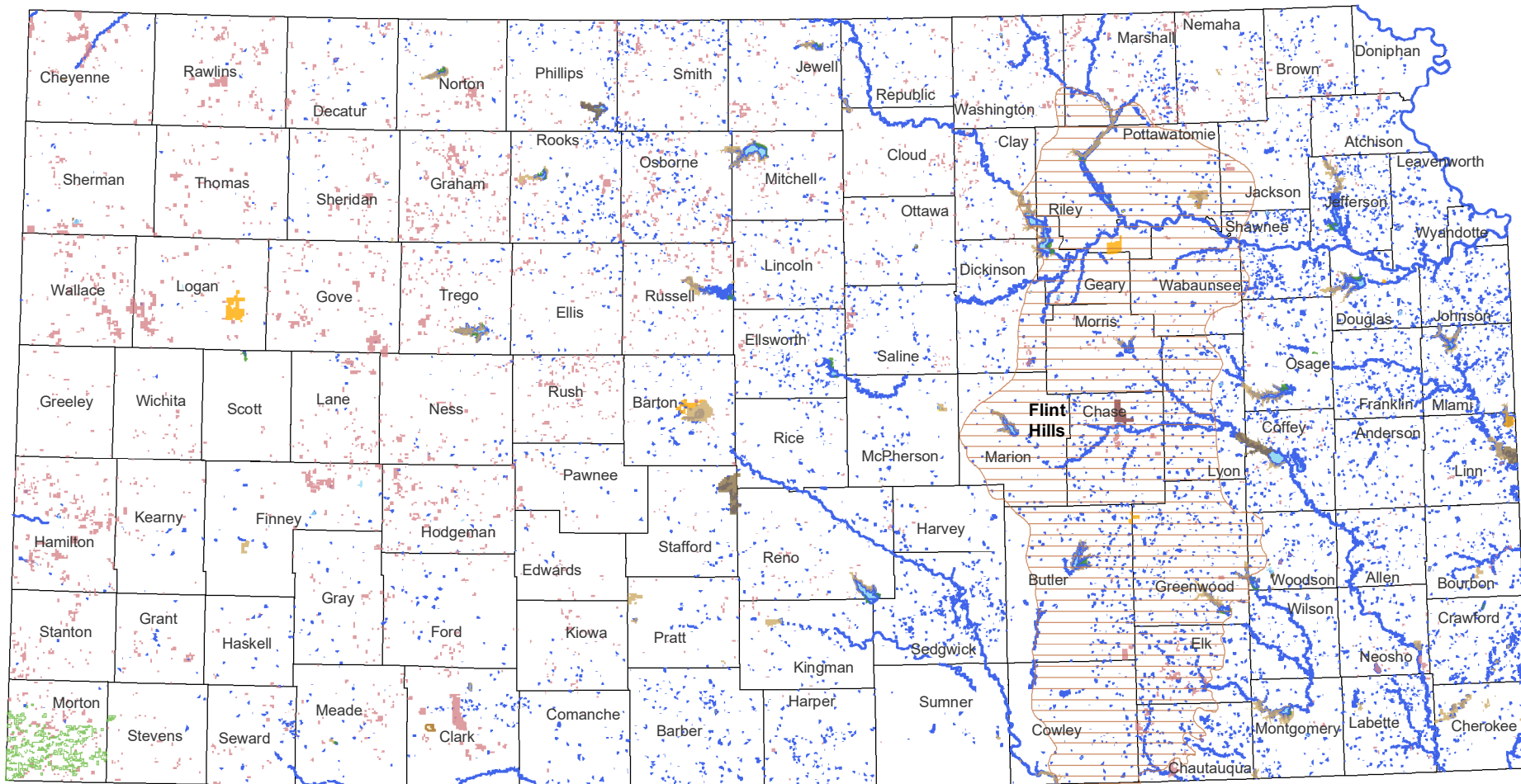
Byways and Natural Attractions in Kansas

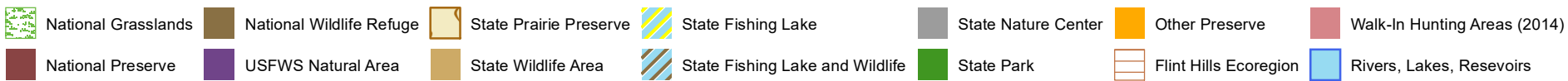
